**There will be a special question for the residents of the City of Udall:**

Shall the following be adopted?

Shall the City of Udall, Kansas, pursuant to the provisions of K.S.A. 12-187, be authorized to renew the levy of a one percent (1%) general purpose citywide retailers' sales tax within the City of Udall, Kansas; such tax, if approved by a majority of the electors voting thereon, to take effect on October 1, 2025, or as soon thereafter as permitted by law, and to end ten years after its commencement on September 30, 2035; the revenue from the renewed tax shall be used for the purposes of defraying the costs of Phase II and Phase III Water Projects for the City of Udall, Kansas; if approved, such tax shall continue the City's current one percent (1%) citywide retailers' sales tax levied within the City?

**There will be a special question for the residents of USD 463:**

Shall a library district be created consisting of all territory located within the boundaries of unified school district No. 463, to be called the Udall Area Public Library District, and a tax in the amount of 1.15 mills be levied to support the library district; all pursuant to the provisions of the Udall Area Public Library District Act, L. 2024, ch.107, §§ 9 through 16?

**There will be a special question for the residents of USD 470:**

Shall a library district be created consisting of all territory located within the boundaries of unified school district No. 470, to be called the Arkansas City Area Public Library District, and a tax in the amount of 5 mills be levied to support the library district; all pursuant to the provisions of the Arkansas City Area Public Library District Act, L. 2024, ch.107, §§ 1 through 8?

The voting hours for said General Election will be from 7:00 am to 7:00 pm, November 5, 2024.

The voting places in Cowley County shall be as follows:

Qualified electors residing in the **city limits of Arkansas City**, will vote at, **Central Christian Church**, 206 W. Central, Arkansas City.

Qualified electors residing in the **city limits of Winfield**, will vote at, **First United Methodist Church**, 1000 Millington, Winfield.

Qualified electors residing in **Beaver and Pleasant Valley Townships**, will vote at **Pleasant Valley Township Hall**, 22277 71<sup>st</sup> Road, Winfield.

Qualified electors residing in **Bolton Township**, will vote at Bolton Township Hall, 6789 322<sup>nd</sup> Road, Arkansas City.

Qualified electors residing in **Cedar, Dexter (including Dexter City), Grant, Otter and Spring Creek Townships**, will vote at **Dexter City Building**, 113 S. Main, Dexter.

Qualified electors residing in **East Creswell (including Parkerfield) and Silverdale Townships**, will vote at **Parkerfield Community Center**, 29271 91<sup>st</sup> Road, Parkerfield.

Qualified electors residing in **West Creswell Township**, will vote at **Central Christian Church**, 206 W. Central, Arkansas City.

Qualified electors residing in **Fairview, Liberty, Salem, Tisdale, Vernon and**

**Walnut Townships**, will vote at, **First United Methodist Church**, 1000 Millington, Winfield.  
Qualified electors residing in **Harvey, Omnia (including Atlanta) and Richland Townships**, will vote at **Cornerstone Christian Church**, 422 Main, Atlanta.  
Qualified electors residing in **Maple(including Udall), Ninnescah (including Udall) and Rock Creek Townships**, will vote at **Udall Community Building**, 102 E. 1<sup>st</sup>, Udall.  
Qualified electors residing in **Sheridan, Silver Creek (including Burden) and Windsor (including Cambridge) Townships**, will vote at **Burden City Building**, 401 N. Main, Burden.

Pursuant to K.S.A. 25-2430 Electioneering on Election Day within any polling place or within 250 feet from the entrance is prohibited. Electioneering means any attempt to persuade or influence by any means, eligible voters, to vote for or against a particular candidate, party or question submitted. Electioneering at polling places is a class C misdemeanor.
